- B. **MWCJUL25-100** A Resolution approving, acknowledging, and accepting the collection of cash in the amount of Forty dollars and Three cents (\$40.03) (\$37.75 in revenues and \$2.28 in Navajo Nation Sales Tax at 6%) generated from service charges, and to submit a revenue budget of \$37.75 for chapters activities fund under the general funds category.

Martha Saggboy, President, explained that these funds were carryover funds. Meredith Benally inquired about what training is available to CLUP&Z members. Martha Saggboy, President, explained that the ASC Office with Kayenta was uncooperative, but the individual we were working with is no longer there.

The final vote for the section was 18/00/02 with the Chapter President not voting.

- E. **MWCJUL25-103** Approve to request the Resources and Development Committee (RDC), the Budget and Finance Committee (BFC), the Naa Bik'i Yati'i' Committee, and the 25th Navajo Nation Council to allocate additional funds for Capital Improvement and Equipment budget shortfall for FY 2026 in the amount of \$832,041.00.
- F. **MWCJUL25-104** Approve to request the Resources and Development Committee (RDC), the Budget and Finance Committee (BFC), the Naa Bik'i Yati'i' Committee, and the 25th Navajo Nation Council to allocate additional funds for Chapter Operation budget shortfall for FY 2026 in the amount of \$77,400.
- G. **MWCJUL25-105** Approve to request the Budget and Finance Committee to approve the allocation of Gaming Revenue to the 110 Navajo Chapters; Reaffirming Equal Distribution; Amending the use of the fund to support local government operations, governance activities and chapter-managed programs; and authorizing direct deposit or system access to initiate and process approved disbursements.

MWCJUL25-107 Approve the request of the Utah Dineh Advisory Committee (UDAC) and the Utah Navajo Trust Fund Board of Trustee (UNTF BoT) to assist Melvin Redhorse/Jenelia Benally with 24x40 house \$115 = \$110,400 (\$60,400 more would be needed from UNTF for labor funds), from the chapter funding allocation. He was approved and given building supplies through the Navajo Revitalization Fund (NRF) 5 years ago. The chapter officials gave a directive to research the prior resolution and find out the amount of funds approved as an amendment. UDAC & UNTF BoT has assisted them with paying the cost for legal boundary survey, archaeological clearance and the biological evaluation using UNTF funds for the new home site lease.
- J. **MWCJUL25-108** Approve to request authorization to use the Agriculture Infrastructure funding (AIF) in the amount of \$7,832.08 due to the drought conditions using the recent Emergency Declaration issued by the Navajo Nation that the chapter had acknowledged.

Meredith Benally MOTIONED to approve resolutions from item E to J, seconded by Carmelita Sagg.

The final vote for the section was 18/00/02 with the Chapter President not voting.

Martha Saggboy explained each item to the community members; she included on item G Northern Edge and Fire Rock Casino are the only casinos making money; therefore, Twin Arrows Casinos is not making any money due to a loan. Item H Martha Saggboy,

President explained that the Navajo Nation was not paying their allocation on time, for instance they were supposed to pay Chapter in March, but they paid out until June. Item I Martha Saggboy, President explained due to changes with Navajo Utah Trust Fund Mr. Redhorse was approved for \$60,400 for labor.Under Item J Martha Saggboy, President explained insurance proceeds for Farmers/livestock owners. As a farmer, a picture of your farm can be submitted for financial assistance.
